NOTE: Dues payments to SENMHBA are not deductible as charitable contributions for federal income tax purposes. However, dues payments may be deductible as ordinary and necessary business expense, subject to exclusion for lobbying activity by NAHB and NMHBA.

For 2021, NAHB estimates that the non-deductible portion of **national** dues — the portion that is applicable to lobbying — is 18%. Thus, for a member who pays their NAHB dues of \$198.00 in 2021, 18% or \$35.64 will not be eligible for deduction as a business expense. Similarly, for an affiliate member who pays their NAHB affiliate dues of \$5.00 in 2020, 18% or \$0.90 will not be eligible for deduction as a business expense.

For 2021, NMHBA estimates that the non-deductible portion of **state** dues—the portion that is applicable to lobbying is 8.8%. Thus, for a member who pays their NMHBA dues of \$145.00 in 2021, 8.8% or \$12.79 will not be eligible for deduction as a business expense. Similarly, for an affiliate member who pays their NMHBA affiliate dues of \$20.00 in 2021, 8.8% or \$1.76 will not be eligible for deduction as a business expense.
